<u>Treasurer's Report, Rose Smith</u> consisting of Balance Sheet Detail, Profit & Loss, and Profit & Loss vs. Actual as of May 31, 2017 was approved by motion Barry Meinerth and second by Sarah Rath.

## Expenses paid:

## Capital expense:

Heater installation came in under budget. Actual cost was \$1621.03

## Investments:

Fidelity has increased in value and we received a dividend

## Heating expense:

Rose presented a pre-buy proposal for propane. Recommended fixed rate for next year 400 gallons \$919.60 with \$20 discount paid before July 1, 2017. The pre-buy was approved by motion Rose Smith and second by Sarah Rath.

#### Facilities:

Steve Williams moved and second by Judy Coolidge to reimburse Bob Morlino for mold remediation work at the Chapel. Motion approved.

Motion made by Rose Smith and second by Theresa Jones to purchase three sets of window black out shades for the Archive room at the chapel. Motion was approved.

Rose Smith moved and second by Sarah Rath to purchase an window GE 6000 BTU air condition unit for the Archive room at the chapel at cost of \$179. Motion was approved.

Rose Smith moved and seconded by Sue DiChiara to purchase a new smoke detector for North Pawlet building. Motion was approved.

On-going needed facilities' issues: Chapel needs storm windows installed, dehumidifier drain (Steve will contact Bob Morlino), security at the Chapel (will discuss with the Cemetery Society, Marlee Mason to ask Keith). North Pawlet building needs brick repair work. Barry will contact Greg Colm

Plan to move the collections from North Pawlet to the Chapel by the end of July.
